The **Ministry of Health and Quality of Life** invites bids from eligible and qualified bidders for the **Procurement of Laundry Services for Hospital Clothing– MHPQ/WKS & S/2015-2016/Q18**, as more fully described in the bid documents. Bidding exercise shall be conducted through Open Advertised Bidding (International) procedures according to the rules and regulations of Mauritius.

**The Contract shall be on fixed rates for 3 years renewable after first year on a yearly basis for a maximum period of 2 years subject to satisfactory performance of the service provider.**

2. Qualifications requirements include:

- (i) Bidders having technical capacity, resources and sound financial situations, and
- (ii) as per other qualifying criteria mentioned in the Bid Document.
