Special Conditions for tendering :

1. Offers should be accompanied with the valid registration certificate issued by the Cosmetic Devices and Drugs Authority in Sri Lanka
2. Offered item should bear both our SR number and the Item number.
3. However at the tender opening only the item numbers will be read out. Therefore price quoted should be shown against each item number.
4. Offers should be on C & F (CPT/CFR) Colombo basis. FOB offers are not acceptable. Total value of each item not exceeding LKR 1 Million for Import and Supply basis is acceptable. Offers exceeds this amount should be on C & F basis. This is not applicable for local manufacturers.
5. Fax/E-mail offers directly sent to State Pharmaceuticals Corporation are not acceptable. Tenderers are requested to draw their attention to the clause "Submission of Tenders" of the tender document in this regard.
6. If awarded supplier is unable to adhere the delivery schedule due to no fault of the SPC/Ministry would result in the supplier being surcharge 0.5% of total bid amount per day from the due delivery date.
7. We reserve the right to reject offers which do not comply above.
8. The original payment receipt has to be annexed to the offer. Offers without same will be rejected

General Conditions apply in the event of an award :

1. To be supplied from freshly manufactured stock.
2. The products should have a minimum of 36 months shelf life at the time of delivery at Medical Supplies Division.
3. Each individual item to bear Description of Item, Batch No., Order List No., Indent No., Name and address of Manufacturer, Date of Manufacture, Date of expiry, SR No., and "STATE LOGO" of Sri Lanka Government.
4. All inner and outer boxes/cartons of surgical consumables should be labeled indicating following details in English in clearly visible manner.
 - (a) Description of item
 - (b) SR No., Date of Manufacture, Date of Expiry and Batch Number - in size 5cm letters/figures in prominently visible manner.
 - (c) Name and address of Manufacturer
 - (d) MSD order list No., SR No., SPC Indent No.
 - (e) "STATE MARK" of Sri Lanka Government.
5. The item shall be suitably packed to be stored under normal room temperature and humidity prevailing in SRI LANKA.

6. The batch quantities shall be identical and number of Batch Numbers shall be minimal. Each batch quantity should be individually shrunk wrapped and palletized.
7. Barcode (Code 128) for Batch Numbers shall be printed on the labels of innermost to outermost packing's as described below.
 - a) Batch number should be separately bar-coded.
 - b) Format should be according to CODE 128 standard.
 - c) Maximum barcode size should be 2.5cm x 5.0cm
 - d) Industry standard in barcode printing and pasting should be followed.
8. Offers for any other economically viable pack sizes different from the specified pack sizes are acceptable with the prior approval of Director, Medical Supplies Division.
9. MSD Order List No. "MSD/SC/024/13/S", SR No., Description of Item, Storage conditions of the item, Batch No., Date of Manufacture, Date of Expiry of Item and SPC Indent no. should be indicated in all Supply Invoices and Packing Lists.
10. Any deviation of the labeling requirement requested by Director, Medical Supplies Division the labels of primary pack of the consignment shall be brought to the particular attention of Director, Medical Supplies Division for the prior approval.
11. In case the item is not delivered according to the given delivery schedule or non compliance of labeling requirement, specially the barcode labeling, Director, Medical Supplies Division has the right to reject the whole consignment or part of it delivered thereafter.
12. If any purchases have to be made by Medical Supplies Division to ensure continuity of supply, owing to delaying/ defaulting the supply on this order, any excess expenditure incurred over & above indented cost of this order shall be debited to SPC, to be recovered by the supplier.
13. To be supplied as per the delivery schedule indicated in the order list.
14. In addition to the condition given herein any other relevant conditions as per the tender document issued by SPC are also applicable.
15. In the event of an award made to you on this tender, SPC reserve the right to cancel/suspend the procuring of said order in any stage, if you would be placed the defaulted supplier's list due to quality failure found in your previous supplies made to SPC or non compliance of contractual agreement

Sufficient quantity of Samples should be forwarded for evaluation.

All tenderers should furnish an unconditional Bid Bond encashable on demand to the value of 2% of item or instances where the total Tendered Price of item exceeds LKR 5 million. Bid Bond should be submitted together with the tender
