- v. Experience of similar work over past 05 years with Public Sector/Banks
- vi. Any other relevant information, which the firm intends to submit.

Bidding document containing detailed terms & conditions, method of procurement, procedure for submission of bids, bids security, bid validity, opening of bid, evaluation criteria, clarification / rejection of bids, performance guarantee etc are available for the interested bidders at the office of undersigned. Interested bidders may inspect the site and obtain Tender Document on any working day between 10:30 a.m. to 04:30 p.m. up to 13/12/2017 on payment of Rs. 1,000/- in shape of pay order in the name of Account Officer TDAP. Following documents are required for obtaining the tender document.

4. The last date of submission of tender is 14/12/2017 up to 11:00 a.m. Bids will open on same date at 11:30 a.m. in front of tender opening committee and the representative of participating firms.
