2. Tenders should be from manufacturers or authorized suppliers of Rice and Footballs.
3. On rejection of Technical Proposal, the Financial Proposal will be returned unopened. The Authority will not be responsible for any opening of Financial Proposal, where it is submitted collectively with Technical Proposal or found opened on submission or not properly sealed.
4. Call deposit in the favor of "Account Officer Trade Development Authority of Pakistan" for Rs. 15000/- or more should be attached with Financial Bid.
5. Earnest Money will be forfeited in case of failure in supply of goods as per time specified in work order.
6. Bids received through fax / telex / email and after the due date/time will not be considered.
7. Attested copies of Income Tax and Sales Tax certificates / documents should be furnished by the firm along with technical Bid.
8. The successful firms will be responsible to deliver the items to the beneficiary in **DAKAR, SENEGAL** with complete documents/accessories.
