- iii. Affidavit to the effect that the firm is not blacklisted and is not in litigation with any organization / department, private or public.
- iv. Copy of NTN Certificate, SRB & STN Registration
- v. Financial soundness, bank statement for at least 12 months
- vi. Experience of similar work over past 05 years with Public Sector/Banks
- vii. Any other relevant information, which the firm intends to submit.

Bidding document containing detailed terms & conditions, method of procurement, procedure for submission of bids, bids security, bid validity, opening of bid, evaluation criteria, clarification / rejection of bids, performance guarantee etc are available for the interested bidders at the office of undersigned. Tender Document can be obtained on any working day between 10:30 a.m. to 04:30 p.m. up to May 26, 2017 without any cost. Following documents are required for obtaining the tender document.

- i. Request on Company Letter Head
- ii. Copy of NTN & SRB Certificate

4. The last date of submission of tender is May 29, 2017 up to 11:00 a.m. Bids will open on same date at 11:30 a.m. in front of tender opening committee and the representative of participating firms.

5. The Earnest money equivalent to 2% of the bid amount shall be furnished with the tender in the shape of call deposit / pay order from the scheduled bank in favor of Accounts Officer TDAP, Karachi. No tender will be valid without earnest money.

6. Trade Development Authority of Pakistan reserves the right to reject any or all the bids and to annul the bidding process at anytime, however, reasons for rejection or annulling the bid process will be communicated to the concerned bidder(s) in accordance with PPRA rules.
