2. **Copy of NTN Certificate.**
3. **Copy of Sales Tax Registration.**
4. **Affidavit that the firm is not blacklisted in any Government Department.**
5. **Details of employees with their respective qualifications / experience.**
6. **Details of company's Infrastructure.**
